Dear Rector Debik:

At their April 18-19, 2025, meeting, the Directors of the National Architectural Accrediting Board (NAAB) reviewed the application for Yildiz Technical University's Continuing International Certification. The Directors granted Continuing International Certification with an Interim Progress Report (IPR) to the Bachelor of Architecture degree (160 credits) degree for a term of six years, effective January 1, 2024. The program is scheduled for its visit for Continuing International Certification in Spring or Fall 2030.

Based on the NAAB review, the Board determined that the program is required to submit an IPR to address the following Conditions and/or Student Performance Criteria (SPCs) identified as not-met, by **November 30, 2027**. NAAB will provide the program director a template for the report, as well as information regarding the next site visit, under separate cover.
